# IMEXHS wins new radiology services contract

The agreement includes a fixed monthly package of 1,500 MRI studies with an option to increase this volume. The new deal requires no capital expenditure and the Company will make use of the medical facilities across RIMAB's network of partners. RIMAB will use the IMEXHS Enterprise Software which is priced into the contract.

The Company has already commenced operations and billing of this contract during February 2023.
