Completion of Unmarketable Parcel Sale & Share Sale Facility

IMEXHS Limited (ASX: IME) (**IMEXHS** or the **Company**) advises that it has today successfully closed its Unmarketable Sale and Share Sale Facility, which was announced to the Australian Securities Exchange on 28 July 2020.

A total of 804 of shareholders were eligible to participate in the Unmarketable Parcel Sale. Of this total, 86 opted to retain their unmarketable parcels and 1,003,505 of shares were sold on-market pursuant to the Unmarketable Parcel Sale at no cost to the participating shareholders.

Through the Unmarketable Parcel Sale, unmarketable parcels have reduced significantly from 48.9% of 1,645 of holdings on 27 July 2020 to 9.1% of 1,287 holdings at 18 September 2020, representing only 0.05% of the Company's issued capital.

A total of 157 of shareholders were invited to participate in the Share Sale Facility of which 2.6% opted to participate, resulting in the on-market sale of 139,000 shares at no cost to participating shareholders.

The reduction in shareholder numbers achieved through the above initiatives will deliver future benefit to remaining shareholders through lower ongoing corporate costs.
