### IMEXHS renews software contracts

#### Highlights

- IMEXHS renews Enterprise software contract with large Healthcare group, Colsubsidio with improved terms and pricing. The 3-year contract is expected to contribute \$575,000 in Annualised Recurring Revenue.
- A second Enterprise software contract with Clinica Medical renewed for 2 years with Annualised Recurring Revenue of \$425,000.

**IMEXHS Limited (ASX: IME) (“IMEXHS” or “the Company”)** today announces that IMEXHS has successfully renewed two important software contracts.

The recurring revenue contract with Caja Colombiana de Subsidio Familiar (“Colsubsidio”), a large Family Compensation Fund in Colombia, providing benefits to Colombian workers, including healthcare benefits was renewed with improved terms and pricing.

Colsubsidio is one of the largest multisite radiology facilities in Colombia, catering to a sizeable patient population. Colsubsidio currently has 25 sites running with approximately 60,000 studies per month.

The renewed contract has a Total Contract Value (TCV) of \$1.7m over 3 years.

The Company also renewed and upgraded another contract with a current client, Clinica Medical. The renewed agreement has an Annualised Recurring Revenue of \$425,000 and a term of 2 years. The new contract has improved pricing and an larger scope of services.

IMEXHS Co-Founder and CEO Dr German Arango said, “We are very pleased with these two important renewals which show our strength in providing cutting edge medical imaging technology over many years. This a testament to the sustainability of our ARR.”
